## Navigator Funding Recommended Grant Awards to Connector Entities

MHBE Board of Trustees Meeting May 16, 2022



#### **Navigator Program Grants**

- ✤ 3-year cycle beginning FY 23 with two, one-year options
- \$10M per year to be distributed to each region with dedicated amounts for outreach based on the remaining percentage of uninsured
- After significant input from stakeholders, the Connector Program will refocus on hyper-local outreach and application and enrollment assistance for new enrollees through localized service centers
- Fewer Navigators, more outreach workers, more bilingual staff
- Outreach goals and new enrollment targets
- Full CE Regions reduced from 8 to 7 to concentrate resources where needed (Mid West will have one regional contact reporting to Central CE grantee)



## Grant Application Timeline

- Current Grants end on June 30, 2022
- RFA Issued March 8 and Closed April 21, 2022
- 12 Letters of Intent for 7 regions, including current grantees
- MHBE received 8 proposals for 7 regions
- 7 proposals met grant application requirements
- Applications from current grantees, but with new partnerships to support new focus

Areas of high uninsured were identified by PUMA (microdata areas)



Grantees were freshly charged with concentrating outreach and new enrollment services in these areas



All grantees must have an outreach center in their region's PUMA/s from which to coordinate grassroots engagement



Community outreach workers to be hired from within community of need


