IT Services IDIQ Advantages

MARYLAND HEALTHBENEFIT EXCHANGE

Cost Effectiveness

- Competitive pricing for highly qualified resources
- Current IDIQ blended hourly rate is ~30-50% lower than prior FFP IT contract rates

Flexibility

- Ability to on-board resources faster and deliver projects on-time in an environment of changing priorities
- Strong IT State staff that can closely manage resources and successfully execute complex projects makes hiring targeted skill sets advantageous

Lower Risk

- Core system functions are vendor agnostic. Current System Operations vendor and hosting vendor complement the in-house IT team, and assume operational risks
- Risk of vendor non-performance is mitigated through distribution of resources across vendors and by the flexibility to hire replacements quickly

Encourage small business participation

• Small businesses can actively compete to provide limited or niche' services
