Statewide Medicaid Check-In Campaign

- Maryland Managed Care Organization Association (MMCOA) solicited marketing firm GKV to create and manage a statewide unwinding campaign.
 - MMCOA is contracted with GKV; collaborative effort between MDH, MCOs, and GKV.
 - MDH provided incentive money to the MCOs to put towards the campaign.
- Coordinated with other state agencies.
 Key Objectives:
 - Encourage Medicaid participants to update their information.
 - Generate awareness of the redetermination process statewide using an integrated mix of vehicles that reflect the audience's media preferences.



 MDH, MMCOA, and GKV are continuously assessing the campaign and identifying areas for improvement, targeted outreach, and additional materials.

Federal Authorities to Drive Innovation and Coverage Retention

- Maryland has 15 federal authorities and/or disaster plans in place tied for third in country
 - Renewal for Individuals Based on SNAP Eligibility
 - Permit Managed Care plans to provide assistance to enrollees to complete and submit
 Medicaid renewal forms
 - Renew Medicaid Eligibility for Individuals with Income at or Below 100% FPL and No Data Returned on an Ex Parte Basis
- 12 Months Continuous Eligibility for Children launched in August 2023 (four months prior to federal mandate)



Improving Enrollment and Eligibility Processes - Ex Parte

- In mid-August, CMS identified a Medicaid unwinding compliance issue with "ex parte" (automatic or passive) renewals that impacted 30 states
 - This issue revolves around whether states conduct this review at the household or individual level - primary concern is impact on children
- Maryland responded immediately to:
 - Pause all procedural terminations for the months of August October while system changes implemented
 - Reinstated coverage for children <19 5,153 children and 10 former foster care youth = 5,163
 - System changes for MHBE and MDTHINK were fully tested and moved to implementation on September 29, 2023

Summary of Redetermination Data for September 2023

- Total participants up for renewal with a September 30 coverage end date¹: 116,601
- Total participants auto-renewed in Maryland Health Connection: 62,659 (69.5%)
- Individuals who no longer qualify for Medicaid through Maryland Health Connection may qualify for coverage through a qualified health plan or Medicare.
- Please note that Maryland has prioritized those most likely to be ineligible for renewal in the first six
 months of unwinding. This includes people who have income overscale, people who have other coverage
 such as Medicare, or have aged out of their coverage group.

*Maryland has paused procedural terminations of Medicaid participants for the month of August in accordance with recently released CMS guidance. Approximately 19,435 procedural terminations would have closed for MAGI. Non-MAGI procedural terminations for the month of September cannot be estimated due to system limitations; they will be reported as a part of the November 2023 report.

Coverage Extension Rate

455,150 / 638,602 = 71.2%*

Procedural Termination (e.g., not returning paperwork) Rate

- 66,044 / 638,602 = 10.3%*
- 105,417 / 638,602 = 16.5% without pause

Ineligible Rate (referrals to QHP):

65,292 / 638,602 = 10.2%*

Procedural Termination by Month

May 2023: 20.5%

June 2023: 12.3%

July 2023: 16.6%

August 2023 (without pause): 14.6%

September 2023 (without pause): 14.2%




Using Data to Pivot Outreach Opportunities

- Nearly 60% of the combined procedural disenrollment activity for May July is concentrated in 60 zip codes
- When comparing each individual cohort file, there is significant overlap in the zip codes with the highest procedural disenrollments
 - Of the Top 10 zip codes for July, 8 of those zip codes were also in the Top 10 for May and June
 - Of the Top 30 zip codes for July, 22 of those zip codes were also in the Top 30 for May and June
 - Of the Top 60 zip codes for July, 47 of those zip codes were also in the Top 60 for May and June



Instances spread into neighboring areas of Baltimore City (Central, South and Northeast) and Baltimore County (Halethorpe, Randallstown, Nottingham and Catonsville)





Revised Media Plan

- Convenience and Laundromat Stores 35 zip codes print and expand to digital presence
- New light rail advertising in Baltimore
- Expand radio buys in Washington DC, Hagerstown and Frederick; maintain current radio in Baltimore and Salisbury
- Bus shelter expansion in Hyattsville, Prince Georges, and Silver Spring;
 current bus shelter coverage in Baltimore City and Montgomery County
- Expand billboard advertising to Hagerstown and Frederick
- Expansion of paid search to include additional search terms



6th best nationally on renewal rate


6th best nationally on disenrollment rate



NOTE: Based on the most recent state-reported unwinding data available. Time periods differ by state. Rates are calculated as total dissenrollments divided by total completed redeterminations (number whose coverage was renewed + number dissenrolled) and total renewals divided by total completed redeterminations; pending renewals are excluded. The dissenrollment rate for MA could not be calculated because MA that are taken from the state's unwinding dashboard, which provides the most up-to-date information on total dissenrollments but does not provide the number of people whose coverage was renewed.
