Re: Instructions on Meeting the Essential Community Provider Plan Certification Standard

Pursuant to COMAR 14.35.16.07, all issuers participating in Maryland Health Connection must submit Essential Community Provider (ECP) information to the Maryland Health Benefit Exchange (MHBE) as a part of plan certification. MHBE collects this information via proprietary templates that are shared annually with issuers prior to submission.

For the 2025 plan year there are no material changes to the submission and review processes. Issuers must submit all ECP related templates and documentation into their SERFF Binders for processing by MHBE Plan Management by June 3, 2024.

ECP Network Inclusion Standards

In the <u>2023 Notice of Benefit and Payment Parameters</u>, the US Department of Health and Human Services has finalized changes to ECP Network Inclusion Standards for the 2023 plan year and beyond to raise the ECP threshold to 35 percent.

To meet the Network Inclusion Standard issuers must:

- a. Contract with at least 35% of available ECPs in each plan's service area as part of each plan's provider network.
- b. Issuers must offer contracts in good faith to the following provider types:
 - All available Indian Health Care Providers in a service area
 - Any willing local health department in the plan's service area, and
 - At least one ECP in each ECP category in each county in the issuer's service area, where an ECP in that category is available and provides medical or dental services by issuer plan type.

MHBE List of ECPs:

MHBE's ECP list is sourced from two documents; the Final Non-exhaustive Health and Human Services list of ECPs for the current plan year and from a list provided by the Maryland Department of Health (MDH) that includes Expanded Essential Community Providers, as defined under 45 CFR §156.235(c).

The ECP list for plan year 2025 includes a total of 2,015 providers. Of that number, 553 are new records from last year's ECP list and 75 are Stand-Alone Dental Providers.

Submission of the MHBE ECP Templates:

Issuers will use the MHBE-developed ECP Templates to report to MHBE which ECPs they have contracted for their networks. The ECP Template will be submitted to SERFF.



Appendix A has detailed instructions on how to complete the ECP Templates. The templates can be found on the website at <u>https://www.marylandhbe.com/carriers/</u>.

MHBE's ECP Calculation Methodology:

MHBE will count individual providers located at one physical location each as a provider for the denominator. Issuers may elect one of two different methodologies to meet the ECP Network Inclusion standard:

- a. Standard denominator: MHBE will use the full list of providers as an issuer's denominator for evaluating compliance with the contracted ECP network inclusion standard. MHBE is confident that the ECPs on the provided ECP List will meet issuer credentialing standards. This is the default denominator method.
- b. Credentialing standard adjusted denominator: In cases where issuers determine they are unable to contract with a significant number of ECPs, such that they will be unable to meet the network inclusion standard using the standard denominator, they may elect to use an adjusted denominator. The issuers must show that their differences in credentialing standards would adversely affect issuer network quality if they contracted with the ECP. Note that ECP credentialing standards/contracts are subject to MHBE review.

MHBE will use the equations below to determine whether issuers meet their ECP network inclusion standards:

For the standard denominator method:

$$Issuer_{1} (\%) = \frac{Number of contracted ECPs + "Write in" ECPs}{Total N of ECPs} \times 100$$

Example:

Insurance Company, LLC., contracts with 705 ECPs, out of the total 2,015 ECPs statewide, so their calculation would be:

$$\frac{705}{2,015} \times 100 = 35\%$$

For the credentialing standard adjusted denominator:

$$Issuer_{2} (\%) = \frac{Number of contracted ECPs + "Write in" ECPs}{(Total N of ECPs - Uncontracted ECPs)} \times 100$$

Example:

Insurance Carrier, Inc., contracts with 700 ECPs and lists 5 ECPs on the "Uncontracted ECPs" tab with explanations of why they could not contract with them, so their calculation would be:

$$\frac{700}{2015 - 5} \times 100 = 35\%$$



To Meet the Alternative ECP Standards when ECP Network Inclusion Standards are Unmet:

If an issuer cannot meet the ECP network inclusion standards, the issuer may satisfy the ECP requirement under the alternative ECP standard. To meet the alternative ECPS standard, an issuer must submit a satisfactory narrative justification that the carrier includes access to sufficient ECPs within its network. Issuers must demonstrate through this narrative that low-income members receive appropriate access to care and satisfactory service. The narrative explanation should describe the extent to which the issuer's provider sites are accessible to, and have services that meet the needs of specific underserved populations including:

- a. Individuals with HIV/AIDS (including those with comorbid behavioral health conditions).
- b. American Indians and Alaska Native (AI/AN).
- c. Low income and underserved individuals seeking women's health and reproductive health services; and
- d. Other specific populations served by ECPs in their service area.

Issuers submitting a narrative justification must also submit to MHBE provider quality and patient satisfaction metrics such as current year and previous year issuer performance on the CAHPS including all CAHPS Composites against the 90th Percentile National Benchmark.

These metrics should be submitted in the same report as the narrative justification. Issuers may propose alternative metrics to report to MHBE for the provider quality and patient satisfaction metrics. Such alternatives may include a statistically rigorous CAHPS survey of cost-sharing reduction eligible members.

MHBE ECP Geographic Inclusion Calculation Methodology:

MHBE Plan Management will determine if issuers meet the geographic inclusion standard through the Contracted ECP List submission. Additionally, issuers must self-report the counties without a single ECP in each category and submit the MHBE IDs of the ECPs outreached to in good faith. Issuers must submit this information when they submit their Contracted ECP List. In such cases where MHBE identifies a county that does not meet the geographic ECP standard for a given issuer, the issuer must submit the same information requested in the self-report. Issuers should submit this information to MHBE within 3-5 business days. MHBE will use this information to verify an issuer's attempted good-faith effort to meeting the geographic standard.

Notice of ECP Standard Approval:

MHBE will notify issuers of their performance against the network inclusion standards within ten (10) business days of submission of their ECP Templates on June 3, 2024. Issuers that do not meet these standards and have not submitted the appropriate documentation should work to submit the information with five (5) business days after receiving notice.

Dental ECP Inclusion Standard:

MHBE will follow the FFM approach for evaluation of ECP Network Inclusion for SADPs. SADPs will be considered compliant with the ECP standard if, in their application, they offer a contract in good faith to at least 35% of available ECPs in each plan's service area to participate in the plan's provider network



and offer a contract in good faith to all available Indian Health Care Providers in the plan's service area. MHBE considers the ECP category per county service area requirement not applicable to SADPs, but strongly encourages SADP issuers to contract with at least one Federally Qualified Health Center (FQHC) and any willing Local Health Department (LHDs). MHBE will work with stakeholders to determine if an ECP category per county service area requirement should be imposed in future plan years.

SADPs are indicated on the MD QHP ECP List in column O "Dental Provider" and are aggregated on the tab "2025_SADP_ECP_List". **Please note** there is a separate Dental ECP Template available at <u>this URL</u> under the heading "Plan Certification".

FAQs:

- Can I add ECPs that are not listed on the official ECP list or on the "Select ECPs" tab on the template?
 - Yes, per the instructions shown in Appendix A, you can add an ECP that is not listed on the official ECP list as a "Write-In" ECP by typing "Write-In" in the MHBE number column on the "Contracted ECP List" tab and then inputting the required information (i.e., provider name, organization name, type of ECP, specialty, address, etc.). We also request that you utilize the "Essential Community Providers Petition" found at <u>this URL</u> to submit any Write-In ECPs to be added to the official list.
- What if the information listed for an ECP we are contracting with is incorrect?
 - Please let us know! We do our best to maintain an accurate list, but we realize there will be mistakes and we have created the "Update Existing ECP Request Form" exactly for this purpose. If you don't feel comfortable submitting the correct information via the form, please send the link to the ECP contact you have so they can update their information. The form can be found at <u>this URL</u>.
- I am unsure how to utilize the template, are there instructions?
 - Yes, the appendix A to this document contains step-by-step instructions for utilizing either the ECP or Dental ECP templates, including screenshots and common issues encountered. If you require further help, feel free to reach out to MHBE plan management directly for assistance at any time.
- Is there a way to identify only the Stand Alone Dental ECPs?
 - We have a separate template for the Stand Alone Dental ECPs that can be found at <u>this</u> <u>URL</u> under the heading "Plan Certification". On the <u>published official ECP list</u>, you can identify the Stand Alone Dental ECPs by looking at the "2025_SADP_ECP_List" tab or by filtering column O "Dental Provider" on the "2025_QHP_ECP_List" tab.
- How do I show that we have attempted to contract with an ECP but were unable to?
 - Per the instructions in Appendix A, you can utilize the "Uncontracted ECP List" tab to indicate which ECPs you tried to contract with along with the reason you were unable to contract with them. If you attempted to contract with an ECP not listed on the "Select ECPs" tab or the official ECP list, please submit a response to the "Essential Community Providers Petition" form so we can review the provider for inclusion in the next plan year's ECP list.
- In previous years, we had a lot of errors due to the "Medical FTEs or Bed Count" columns. How do we input the correct number of FTE's/Beds? What if we do not know that information?
 - CMS has removed the FTE/Bed counts from this year's list and MDH had never provided this information, so both templates have been updated to remove these columns. This should cut down on the number of errors encountered on the template as this was a major sticking point previously.
- In previous years, we had encountered issues when copying and pasting content into the Facility and Individual ECP tabs, how can we avoid getting errors when we do this?





- We have recently revised the template significantly to address this issue. You can now copy and paste information into the "Contracted ECP List" tab (which has replaced the Facility ECPs and Individual ECPs tabs) and into the "Uncontracted ECP List" tab. If you encounter errors, please reach out to the Plan Management team as soon as possible for assistance.
- One of the ECPs we contracted with last year is not listed on the "Select ECPs" tab or the official ECP list. Where did they go?
 - Our ECP list is a combination of the official CMS ECP list published each plan year and a list of ECPs we receive from the Maryland Department of Health. We have done our best to remove any duplicated records on the ECP list and ensure that every ECP listed is a valid entry with accurate information. It is possible that in the de-duplication process, a valid ECP was removed. If you encounter this issue, please reach out to us right away and submit a response to the "Essential Community Provider Petition" form so that we can add the ECP back to the official list. We have a full list of all removed duplicated ECPs and ECPs we determined to be invalid that we can check against to determine if the ECP was removed in error.



Appendix A: Template Instructions and Helpful Tips

Essential Community Providers Template Instructions

1. Introduction

This document provides instructions to QHP and SADP issuers on how to use the Essential Community Provider (ECP) Templates (standard or dental) to demonstrate that they meet the requirements of sufficient number and geographic distribution of ECPs. It also allows issuers to utilize the CMS Network ID Template to detail the network(s) associated with each QHP.

2. Data Requirements

To complete this template, issuers will need the following:

- a. HIOS Issuer ID
- b. Completed Network ID Template (provided by CMS on this page)¹
- c. Any Write-in ECPs (qualified ECPs not listed on the MD ECP List PY 2025)
- d. A list of Uncontracted ECPs (if the issuer is unable to meet the reporting requirements using the general ECP standard calculation²) including a brief narrative explaining the steps taken to contract with the ECP and their response.

3. Detailed Section Instructions

¹ NOTE: Network templates with only one network may result in blank lines being populated to the "Network ID" list for the drop-downs on the ECP tabs. Please keep this in mind and be sure to scroll up on the drop-down using the up arrow.

² NOTE: An issuer may not realize they need to be considered under the Alternate ECP Calculation until they have completed the template. Should you encounter this issue, please reference the first topic in the "Troubleshooting Common ECP Template Issues" section for a detailed guide on what to do including helpful tips that will prevent the issuer from having to duplicate efforts they have already done and significantly cut down on revision time.



The first tab of the Essential Community Provider template is the **User Control** tab. This tab contains the issuer identifying information, instructions on the proper order to complete the template, a button to import the Network ID template (which must be completed ahead of the ECP template), a Validate button used to identify any errors, and the ECP counts and ECP contracting requirements calculation (generated by clicking on the "Calculate" button after completing the other steps listed).

A sample completed **User Control** tab looks like **Figure 1**.

Import Network IDs: Click the **Import Network IDs** button to import data from the Network ID Template provided by CMS. Once the Network ID Template is imported, it will automatically populate networks into the **Network IDs** field as a drop-down menu in the **Contracted ECP List** tab. The confirmation message shown in **Figure 2** will display if the import was successful.

Select ECPs Tab	Steps
Filter ECPs	The columns on the Select ECPs tab can be filtered to make selecting ECPs
	easier. For example, filter the Site City column to only view ECPs in "Baltimore".
Add ECPs	 Double-click anywhere on the row for the ECPs the user wants to add to the ECP tabs. Once selected, the row will be highlighted in blue and "ADD" will appear in the "Add ECP?" column. Continue selecting the ECPs until all contracted ECPs from the ECP list are selected. To unselect an ECP, double-click on the selected row. The blue highlighting will be removed, and the ECP will not be added to the ECP tabs. To clear <i>all</i> selected ECPs, click the Clear All button at the top of the tab, and all highlighted ECPs will be deselected and will not be added to the ECP tabs.
	Selected button at the top of the tab, and all highlighted ECPs will be displayed. To undo this action and show all ECPs, click the Show All ECPs button.
Insert ECPs	 Click the Insert Selected button. The selected ECPs will be added to the Contracted ECP List tab. The template will not populate duplicate ECPs into the tabs. The issuer must complete any field within the Contracted ECP List tab that the Select ECPs tab did not populate before the template is validated. For each ECP that was selected and inserted from the Select ECPs tab, a record will be added to the Contracted ECP List tab that includes the following: the MHBE number, NPI³, facility name, provider name, street address, city, state, ZIP, county, and all the ECP categories. You may repeat the "Add ECPs" and "Insert ECPs" steps from this table as needed to populate the Contracted ECP List tab populate with additional ECPs.

To complete the information on the **Contracted ECP List** tab, follow the steps in the table below.

Contracted ECP List Tab	Steps
Physician/Non-Physician	Indicate the type of provider. Choose from the following:
	Physician – if the provider is a physician practitioner.
	Non-Physician – if the provider is a non-physician practitioner.
Specialty Type (area of medicine)	Select the appropriate specialty type for each ECP. Issuers may select multiple specialty type for each ECP, as applicable. If none of the facility type selections apply to the ECP, select 000 OTHER . If the user makes a mistake in selection, they can click the cell to select it and press the "DELETE" button on their keyboard. The cell will be cleared, and the user can start over with their selection.
Network IDs	Select the network IDs for each ECP. Issuers may select multiple network IDs for each ECP, as applicable. Dual issuers must create separate network IDs for their medical and dental plans.

To remove ECPs from the **Contracted ECP List** tab, double-click the record to be deleted in the Remove ECPs column. The provider will be highlighted in blue. Click the **Remove Selected ECPs** button to remove the ECPs from the template.

Issuers proposing Write-In ECPs: If an issuer would like to add a **qualified ECP** that is not contained in the MD ECP list (or on the **Select ECPs** tab), please input all the required information for that ECP on the **Contracted ECP List** tab. In the MHBE Number column, input "Write-In" to indicate this is a write-in ECP that the issuer is requesting be added to the MD ECP list. You must then complete (or prompt the ECP themselves to complete) an entry of the "Essential Community Providers Petition" found at <u>this URL</u> to submit any Write-In ECPs to be added to the official list. Write-In ECPs will be evaluated by MHBE against the Write-In list provided by CMS on their QHP certification website (<u>https://www.qhpcertification.cms.gov/s/ECP%20and%20Network%20Adequacy</u>) and for General ECP Standard Issuers, only those providers who are listed on the ECP Write-In List will count as qualified ECP write-ins.

The **Uncontracted ECP List** tab will be used by issuers who selected yes in response to the "Is this an Alternate ECP Calculation Issuer?" due to being unable to meet the 35% threshold MHBE has set using the general ECP standard calculation. The first topic under the "4. Troubleshooting common ECP Template Issues" section details some helpful tips for completing this section that issuers should consult along with the detailed steps listed in the table below.



Uncontracted ECP List Tab	Steps
MHBE Number	This column contains a drop-down that lists all the MHBE numbers for carriers on the "Select ECP" list. When the user selects a number, the corresponding details will be auto populated to the NPI and Provider Name columns. The user can either select each uncontracted ECP using the drop-down or copy and paste MHBE numbers from the Select ECPs tab.
Reason Unable to Contract	After selecting the MHBE Number from the list in Column B, the user will complete a brief narrative explaining the steps taken to contract with the ECP and the ECPs response or reason the issuer was unable to contract with them.
Remove Selected ECPs	If the user needs to remove an ECP from this list, they can double-click the "Remove ECP?" column, just like on the Select ECPs or Contracted ECPs , to highlight the entire row and click on the "Remove Selected ECPs" button at the top of the tab to delete that row.

The **Errors** tab displays any validation errors identified when a completed MD ECP Template is validated.

- Column A "Tab" indicates the tab that produced the error.
- Column B "Cell" indicates the cell location for the specific error and a hyperlink that allows the



issuer to navigate to the exact cell in the correct tab.

Column C – "Validation Error Message" describes the error.

Reference information is provided in the three tabs listed below:

- The Specialty Type tab contains the specialty/facility types that can be added into the MD ECP Template.
- The County Names tab contains the county names that are used and accepted in the MD ECP Template.
- The **HPSA** tab contains the HPSA and low-income ZIP codes. The issuer can filter by Zip code.

The **Geographic Analysis** tab has been added to allow MHBE to analyze the distribution of ECPs by county and across carrier networks. These data will be compiled to pinpoint areas that may be lacking ECPs and allow MHBE to improve the ECP program statewide to the benefit of consumers on the exchange. To complete the **Geographic Analysis** tab, please follow the directions in the table below:

Once the MD ECP Template is completed, issuers must validate, finalize, and upload the template to SERFF.⁴

Template Validation	Steps
Validate Template	Click the Validate Data button on the User Control tab. The validation process identifies any data issues that need to be resolved. If no errors are identified, finalize the template.
Errors	If the template has any errors, they will appear on the Errors tab showing the data element and cell location of each error. Correct any identified errors and click Validate again. Continue this process until all errors are resolved.

4. Troubleshooting common ECP Template issues

Since the creation of this template in 2018, MHBE Policy and Plan Management has assisted carriers with many common issues or questions about how to complete the template correctly. This section details the most common hurdles carriers have encountered and provides detailed steps to resolve the issue quickly and efficiently. We highly recommend carriers read this section even if you have not encountered issues completing the template as it contains helpful usage "tips" that will certainly improve your experience using the ECP Template or the Dental ECP Template.

I. The user is unable to contract with enough ECPs to reach the designated 35% threshold using the general ECP standard calculation but has proof of their reasonable effort to contract with additional ECPs.

MHBE Policy and Plan Management understands that there are scenarios where the issuer is unable to contract with enough ECPs to meet our threshold using the general ECP standard calculation, often due to the ECP not accepting their plan offerings or a breakdown in communication that is no fault of the issuer. In this scenario, we suggest following these detailed steps to demonstrate that the issuer did attempt to meet the general ECP standard and list out the ECPs they were unable to contract with. It may also be the case that a user does not realize this until they have finished completing the ECP Template or Dental ECP Template and the steps below include helpful tips to ensure the user does not duplicate effort they have already put in on filling out the template.

- 1. If the user has already completed the template, go back, and select and copy all the ECPs on the **Contracted ECP** tab (from cell A2, "REMOVE", to the last row in column Y, "Network IDs") and paste this into a new workbook. The user can skip this step if they have not already completed the template.
- 2. Go to the **User Control** tab and change the dropdown to "Yes" for the question "Is this an Alternative ECP Calculation Issuer?". This will wipe all the ECP data on the Contracted ECP tab (hence why the first step asks the user to copy it to another workbook first).
- 3. Copy and paste the ECP data from the new workbook to the Contracted ECP. Even fully protected, it should allow the user to do this. The user can also skip this step if they are completing the template fresh.
- 4. Go to the Select ECPs tab and clear all previous selections using the green "Clear All" button (if any ECPs are selected).

The next two columns will auto populate when the user puts the MHBE numbers they copied into the "MHBE Number" column. The user can then fill in the "Reason unable to contract" column for each uncontracted ECP.

II. The ECP we have contracted with is not listed on the "Select ECPs" tab.

We recognize that there can be times when a valid ECP has been left off either of the source lists (from the CMS or MDH) or was erroneously removed during de-duplication and as such we provide the option to "Write-in" an ECP on the **Contracted ECP List** tab. The procedure for this scenario requires the user to first input "Write-in" in the MHBE Number column so it is easy for MHBE Policy and Plan Management staff to identify the write-in ECPs, then fill in all required tabs (as indicated by the red asterisk on the column heading). Even though the template is locked, it will still allow the user to input all required information. The user may then complete validation and finalize the template and the ECP(s) will be included in the denominator of the ECP standard calculation.
